T-R-A-I-N-E-D O-F-F-I-C-E-R-S

At the National Convention in Davenport Iowa a Resolution was passed to the effect that National, State and Local Officers could not hold office for more than three consecutive years.

However it was pointed out that they could hold some other office. The sponsor of this resolution explained that in some states personalities were so close it was difficult to remove officers and elect better ones.

Nothing was said in this Resolution about "TRAINING OFFICERS" Nothing was said in this resolution about using STATE OFFICERS for nominations, in the National. Nothing was said about emergencies where no one trained person will accept an office.

What a shock it was to tried officers, who had taken the pains to help our organization, who had taken the trouble to learn about the facts of our Organization, without pay, or remuneration.

Your Assisand Editor of the A.A.M.M. News (and also Washington Delegate attending the National Convention) believes that this resolution should have more study. Possibly before any officers are removed on account of the three year period resolution becomes effective, we can change this resolution to cover some of these difficulties that such a move will create.

One question that is involved is the matter of 3 years itself---How shall it be interpeted? When does the 3 year period begin? --What about Officers now in office? Do they have 3 years yet go go? We can change this by resolution at our next Convention. What problems will this resolution create? Also in our State Set up.

Mr. Samuel Dahlgren says that; This Resolution will take effect Three Years (3 years) from the 1954 Convention.

It seems that this is one of the great weakness of our Organization. Even in Lodges, officers get their office by assention. First you are elected as a petty officer, then you are elecled to a greater office, and after you have served as an assistant in several capacities you are elected (from the advanced group of officers to higher office.

This year for the first time in nine years, the Association has gotten officers that know how to handle the business. What will we do for next year? The Organization is functioning on an "Even Keel" for the first time since its existence, and all our members would like to keep it functioning smoothly and efficiently, so what are we going to do about trained officers?

Your Assistant Editor suggests that Mr. Samuel Dahlgren, chairman of the National Nominations Committee, and Mr. Arthur Mann, Chairman of the Constitution and By-laws committee lead a group study in this matter and come up with a Resolution to present to the National Convention in Frankfurt Kentucky. Possibly members from each state should enter this study and consider how such resolution will apply in each state etc. It is time we get the answer to this problem. --- JUST ANYBODY CAN'T AND WON'T DO AS OFFICERS in the National, or the State or Local. We must have efficient informed men and women to act as officers. Trained officers if you please!

Experience has proved that it takes years to develop an officer so that he knows the ropes--- and that is the kind of officers we need. Probably we should repeal or set aside for this coming year this rule we have so hastily adopted (or maybe Mr. Mann and Mr. Dahlgren can make a substitute rule) which would have better application. CERTAINLY WE DON'T INTEND TO TURN OUT OF OFFICE ALL OUR GOOD OFFICERS AND GET A GROUP OF RAW INEXPERIENCED OFFICERS ALL IN ONE PELL SWOOP! No matter how good the new group of officers may be.....

Let me suggest that each Officer in each state write to Mr. Dahlgren, and Mr. Mann about this matter. It is important that they know what you think--- Then too, how about a ballot to each member to elect the National Officers?

WHAT A MASSEUR CAN DO FOR A SICK PERSONS

In conversation with prospective members, and some members of our Association, over the past several months, I find thereis an opinion among some, (and I believe it is due to misunderstanding, possibly ignorance in some cases) as to what our profession really is, and just what scope it covers.

I will endeavor to voice my limited knowledge upon the profession of Masseurs and Masseuses, as I see it. Hoping it will clarify the minds of some less informed.

To begin with the word masseur as defined in Medical dictionary is, a man who massages. Masseuse is a woman who massages. Massage is, Manipulation, Methodical pressure, Friction and Kneading of the body. Must always be applied on the bare skin.

Massage dates back to almost the beginning of time, as to its natural therapeutic value. It has been developed and improved in technique by the Swedish scientist Dr. Ling and is known as the Ling System.

The early day osteopaths used the Ling system and a number are still using it today, preceding their joint manipulations. Hence the name "Osteopath."

We all know that Scientific Massage properly applied is a very valuable therapy.

Some people that I have talked with, seem to feel that the word MASSAGE is not technical enough. They would like to call our profession something else, such as Naturopath, Myo-oractor, Messo-therapist, Sanapractor or Physical Therapist. The latter is the only one you can find in the dictionary. The other titles are a profession in themselves or a glorified name for a Masseur or Masseuse. aMassage, Hydro-therapy, electro-therapy, Colon Therapy are a part of Physical Therapy it is true, but that does not make a Physical Therapist of a Masseur or Masseuse, because he or she does one or more of these therapys.

So lets stick to what we are and be proud of our profession. If we do so we will have much better co-operation from other professions in the healing arts also.

Instead of entertaining any idea of changing the title of our profession and technician's. I would suggest that every member attend the meetings. Meet other technicians, exchange ideas, learn better techniques, because we do have some well qualified members among us who have had the advantage of good schools, plus a world of experience. If we continue to improve our techniques and educational status we will not be referred to as "mere Rubbers"

When I was being trained as a masseuse, I was taught the art of scientific massage and was told never to refer to massage as a "RUB" or allow any one in my profession to be called a "RUBBER" or an "OPERATOR". But always a MASSAGE TECHNICIAN.

It is up to us as individuals to conduct ourselves professionally so that we will be above the RUBBERS category.

In conclusion I would like to suggest that we have more demonstrations of techniques in our meetings. Dispatch our business with promptness and finality. Ther by helping each other that we will build a bigger and better Association.
