Effective: July 1, 2018 Currentness (a) Each license shall be renewed biennially, on or before the anniversary date, by forwarding to the board a renewal application accompanied by the renewal fee. Each applicant for renewal for licensure shall be subject to a criminal history check. Any license not renewed biennially on or before the anniversary date shall expire. (b) Each licensee, upon application for renewal of a license, shall do both of the following: (1) Submit evidence of satisfactory completion of the continuing education requirements contained in Section 34-43-21. (2) Consent to a criminal history check. Refusal to consent to a criminal history check constitutes grounds for the board to deny the licensee's application for renewal of the license. (c) Licenses are valid for two years from the date of issuance. An individual whose license has expired and who has ceased to practice massage therapy for a period of not longer than five years may have his or her license reinstated upon payment of a renewal fee and a late fee and submission of a renewal application and evidence satisfactory to the board that the applicant has fulfilled continuing education requirements, passed a criminal history check pursuant to rules adopted by the board, paid the criminal history check fee, and passed the examination. (d) Subsequent to an official complaint, the board may request a criminal background check of the licensee through the district attorney of the circuit in which the licensee is located. (a) An applicant for renewal of a massage therapy license, (1) for a biennial licensing period that begins on or after July 1, 2015, must document at least six continuing education credits, all of which may be met through Internet-based continuing education courses; (2) for a biennial licensing period that begins on or after July 1, 2017, must document completion of at least 16 continuing education credits during the concluding licensing period, all of which may be met through Internet based

	<p>continuing education courses;</p> <p>(3) for every other biennial licensing period that begins on or after October 1, 2019, must document that a minimum of two of the 16 continuing education credits required under (2) of this subsection are in ethics;</p> <p>(4) must document completion of a cardiopulmonary resuscitation course as required by 12 AAC 79.200. rapist/Massage-Therapist-Licensure	<p>Number of Hours</p> <p>Each licensee applying for license renewal shall complete a minimum of 24 hours of qualifying continuing education every 4 years.</p> <p>Qualifying CE</p> <p>The continuing education shall be in areas related to the licensee's practice, including, but not limited to, courses offered by providers that are approved by the National Certification Board for Therapeutic Massage and Bodywork. No more than 6 hours of continuing education can be achieved in via Internet-based or distance learning programs. No more than 12 hours can be obtained from programs not approved by the National Certification Board for Therapeutic Massage and Bodywork (NCBTMB). The Department does not approve continuing education courses, pre-approve specific coursework for individual licensees or maintain a list of continuing education courses.</p> <p>Documentation Requirements/Record Retention</p> <p>Each licensee must obtain a certificate of completion from the provider of the continuing education for all continuing education hours that are successfully completed and shall retain such certificate for a minimum of 6 years. Upon request by the Department, the licensee shall submit the certificate to the Department. A licensee who fails to comply with the continuing education requirements, including failure to maintain proof of course completion, shall be subject to disciplinary action.</p> <p>Each licensee applying for license renewal will be asked to attest that the licensee satisfies the continuing education requirements. Certificates of completion should not be mailed to the Department unless a licensee is specifically directed to do so.</p>

Licensees shall complete 24 hours of approved CE during each biennial licensing period. Completion of the required CE hours is a prerequisite for renewing a license. Hours earned in a biennial licensing period in excess of those required for renewal may not be credited towards the hours required for renewal in any other licensing period.</p> <p>9.2 Calculation of Hours. For academic course work, correspondence courses, or seminar/workshop instruction, one hour of acceptable CE shall mean 50 minutes of actual instruction. One academic semester hour shall be equivalent to 15 CE hours; one academic quarter hour shall be equivalent to 10 CE hours.</p> <p>9.3 Pro-ration schedule:</p> <p>9.3.1 If the license is issued more than 12 months prior to the next renewal date, the licensee shall complete 24 hours of acceptable CE during the licensing period.</p> <p>9.3.2 If the license is issued less than 12 months prior to the next renewal date, the licensee shall complete 12 hours of acceptable CE during the licensing</p>

The Board reserves the right to approve less than the number of hours requested or to approve a course in a different category than requested.</p> <p>9.5.3 Self-directed activity. The Board may approve credit for up to 6 hours for self-directed activities, including, but not limited to teaching, research, and preparation or presentation of professional papers and articles. Licensees may apply for pre-approval of self-directed activities by submitting a written request for pre-approval that must include an outline of the scope of the activity, the number of CE hours and category requested, the anticipated completion date, the role of the licensee in the case of multiple participants (e.g. research), and whether any part of the self-directed activity has ever been previously approved or submitted for credit by the same licensee. Research involving hands on protocols may be considered Core CE, at the discretion of the Board, with a limit of 6 CE credits.</p> <p>9.5.4 Course preparation and instruction. The Board may approve up to six additional CE credits, on an hour for hour basis, to instructors for their initial preparation and presentation of an approved CE course (e.g. an instructor preparing and presenting an eight hour course for the first time may receive up to six additional credit hours.)</p> <p>9.5.5 Board approval of a licensee’s CE hours in a modality is not a Board endorsement of the licensee’s competence to practice that modality.</p> <p>9.6 Verification.</p> <p>9.6.1 Verification of CE hours shall be by attestation. (A) A person licensed under this chapter biennially must satisfy these license renewal requirements in order to continue practicing massage/body work therapy:

(1) pay a renewal fee in the amount, at the time, and in the manner as the department provides in regulation;

(2) complete continuing education requirements prescribed by the department in accordance with Section 40-30-190 and submit evidence of compliance; however, a massage/body work therapist who has proof of a "Certificate in Massage" issued prior to January 1, 1974, is exempt from continuing education requirements.

A massage/body work therapist's license automatically reverts to inactive status if the massage/body work therapist fails to timely comply with this subsection and only may be reinstated upon application and payment of any fees and after having met any additional requirements which the department may establish in regulation including, but not limited to, continuing education requirements.

(B) A license which has been inactive for more than four years automatically expires if the person has not made application for renewal of the license. An expired license is null and void without any further action by the department.

TDLR will select for audit a random sample of licensed massage therapists for each renewal month. If selected for an audit, then you will be notified at the time of your renewal. You will be required to submit copies of certificates, transcripts or other documentation to verify attendance, participation and completion of continuing education requirements. If selected for audit, all documentation must be provided at the time of renewal before the license will be renewed.

The licensee is responsible for maintaining a record of continuing education experiences or certificates. If you are selected for audit, then you will be notified and records will be required to be submitted to TDLR.
